#### **Town Board Special Meeting**

#### October 31, 2012

The Town Board of the Town of Cairo met for a special meeting on Wednesday, October 31, 2012 at the Town Hall, Main Street, Cairo, New York.

Supervisor Banta called the meeting to order at 2:00 PM and then asked the attendees to Pledge Allegiance to the flag with all members present

**Resolution No 246-12** "Receipt of Monthly Supervisor's Report"

Councilperson Puorro offered the following resolution and moved its adoption:

WHEREAS, it has been recommended by the NYS Comptroller's Office in the Town of Cairo Report of Examination 2008M-175, that the Supervisor should present a Monthly Report to the Board Members consisting of cash receipts, cash disbursements, and a budget versus actual report for expenses and revenues, and it be documented in the minutes; therefore, be it,

RESOLVED, that the Town Board Members accept the monthly Supervisor's Report for September, 2012.

#### LEASE AGREEMENT

THIS AGREEMENT, dated this 24th day of January 1990 by and between the TOWN OF CAIRO, a municipal subdivision of the State of New York, Landlord and CAIRO FISH AND GAME CLUB, INC., a not-for-profit corporation duly organized under the laws of the State of New York.

WHEREAS, the Town of Cairo is the owner of certain property more particularly described in Schedule A attached hereto, and

WHEREAS, said parcel has been formerly used as a Town Dump and

WHEREAS, said property has not been used for municipal purposes for over twenty (20) years and

WHEREAS, said property is currently littered with debris resulting from said dump operations.

IT IS HEREBY AGREED by and between the parties hereto, for and in consideration of the sum of One (\$1.00) Dollar and the mutual promises and covenants contained herein that:
