**WHEREAS**, the town received grant money for the police department for technological improvements in 2024; and

**WHEREAS**, it is necessary for accounting purposes to track the expenses and appropriations associated with these funds; therefore,

**BE IT RESOLVED**, the Town Board does hereby authorize the Town Supervisor to credit the expense line item A-3120.401 (Police Contractual - Grant) to reflect the increase in General Fund Appropriations \$58,838.00 and; debit the appropriated fund balance A-599 (Appropriated Fund Balance) to reflect the appropriation in General Fund in the amount of \$58,838.00 in the 2024 budget.

# <u>Resolution No. 2024-158</u> "Authorize Implementation and Funding of Bridge NY Culvert Project on Polly Rock Road over Kiskatom Brook"

Offered by Council Member Flaherty and seconded by Council Member Bogins.

WHEREAS, a project for the BRIDGENY/CULVERT NY, BIN 2200580 Polly Rock Road over Kiskatom Brook, Bridge Replacement, Town of Cairo, PIN 1762.02/D040704 (the "Project") is eligible for funding under Title 23 U.S. Code, as amended, that calls for the apportionment of the costs such program to be borne at the ratio of 95% Federal funds and 5% non-federal funds; and

**WHEREAS**, the Town of Cairo desires to advance the Project by making a commitment of 100% of the costs of Construction work for the Project or portions thereof; therefore,

BE IT RESOLVED, that the Town Council hereby approves the Project; and furthermore,

**BE IT RESOLVED,** that the Town Council hereby authorizes the Town of Cairo to pay 100% of the cost of Design and Construction work for the Project or portions thereof, with the understanding that qualified costs may be eligible for federal-aid, state-aid or reimbursement from Bridge NY funds; and furthermore,

**BE IT RESOLVED,** that the sum of \$15,000.00 (fifteen thousand) is hereby appropriated from the Town of Cairo **Highway Funds** and made available to cover the cost of participation in the above phase(s) of the Project; and furthermore,

**BE IT RESOLVED,** that the Town Council hereby agrees that the Town of Cairo shall be responsible for all costs of the Project which exceed the amount of the NY Bridge Funding awarded to the Town of Cairo; and furthermore,

**BE IT RESOLVED,** that in the event the costs of the Project exceed the amount of Bridge NY funding appropriated, the Town Council shall convene as soon as possible to appropriate said excess amount immediately upon the notification by the New York State of Transportation thereof; and furthermore,

**BE IT RESOLVED,** that the Town Council hereby agrees that Town of Cairo hereby commits that construction of the Project shall begin no later than twenty-four (24) months after award and the construction phase of the Project shall be completed within thirty (30) months; and furthermore,

**BE IT RESOLVED,** that the Supervisor of the Town Council of the Town of Cairo be and is hereby authorized to execute all necessary agreements, certifications or reimbursement requests with NYSDOT for State Aid and/or Bridge NY funding on behalf of the Town of Cairo and in connection with the advancement or approval of the Project and providing for the administration of the Project and the municipality's funding of the Project costs; and furthermore,

**BE IT RESOLVED,** that the Town of Cairo will be responsible for all maintenance of the Project; and furthermore,

**BE IT RESOLVED,** that a certified copy of this resolution be filed with the New York State Commissioner of Transportation by attaching it to any necessary Agreement in connection with the Project; and furthermore, **BE IT RESOLVED**, this Resolution shall take effect immediately

**WHEREAS,** a Public Hearing is necessary for the federal aid process and needs to be held before DOT will grant design approval; Therefore,

**BE IT RESOLVED**, that on September 9, 2024 at 7:00 pm, at the Cairo Town Hall, the Cairo Town Board shall hold a Public Hearing.

WHEREAS, it is necessary for Sergeant Richard Busch to place orders utilizing the grant; and WHEREAS, there was a power surge on July 25, 2024 that created extensive damages to the police department servers; therefore,

**BE IT RESOLVED**, that an emergency vote was conducted and Michael Flaherty (email vote), Debra Bogins (email vote) and Jason Watts (phone vote) approved Yama Industrial to install the police department computer server not to exceed \$24,500 out of the \$58,838.00 of the LETECH grand funds; furthermore,

**BE IT RESOLVED**, the Town Board does hereby authorize Sergeant Richard Busch to place orders to spend the remaining grant funds left over for law enforcement technology and equipment identified in the Grant Award Notice attached.
