- Public Hearings to Create a New Water District for South Cairo
  - Public Hearings will be held on Mon. May 5 and Wed. May 21 for discussion about the new Water District in South Cairo and what is required by the Town for the District to be created.

#### Resolution 2025-104 & 2025-105

- Human Services
  - Greene County Human Services contacted the Town Board stating that the Community Center on Route 32 did not have an AED in place. The Board will purchase one.

### **Old Business:**

- Digital Storage Services
  - Brought back up by the Supervisor and there was some discussion on prices and if it was necessary. Currently the price has been budgeted for 2025 and can be done. The current Grant Writer for the Town is looking into a Grant through the NYS Archives but that would not be awarded until next year. *Resolution No. 2025-077*

Intermunicipal Agreement for DCO assistance between the Town of Cairo and the Village of Catskill.

## Resolution No. 2025-089 "Terminate All Energy Supplier Contracts"

Offered by Supervisor Watts and seconded by Council Member Cords.

**WHEREAS,** the Town of Cairo has entered into agreements/contracts with various energy suppliers in the past; and

WHEREAS, after the Good Energy, L.P. contract from 2023-2024 expired, Smartestenergy US, LLC started billing the Town of Cairo at a variable rate based on a previous contract that the Supervisor entered into starting in January 2022 for a one year term; and

WHEREAS, SmartestEnergy US, LLCstated that per their original contract, the term automatically continues at a variable rate until the Agreement is terminated by either party and since the CCA expired in December of 2024, they can automatically bill the Town of Cairo at a variable rate; therefore,

**BE IT RESOLVED,** the Cairo Town Board finds that it is not in the best interest in the Town of Cairo to utilize alternate energy suppliers besides Central Hudson; furthermore,

**BE IT RESOLVED,** that the Town of Cairo would like to terminate any and all supplemental alternate energy suppliers for the Town of Cairo.
