#### **Town of Cairo**

Wednesday August 20th, 2025

Town Board Meeting @ 7:00PM

**Location: Town Hall Meeting Room** 

The Town Board of the Town of Cairo met for a Town Board Meeting on Wednesday August 20<sup>th</sup>, 2025, at the Town Hall, Main Street, Cairo, New York. The meeting was called to order @ 7:00PM and asked the attendees to Pledge Allegiance to the Flag.

Attendance: Supervisor Watts, Council Member Bogins, Council Member Cords, Council Member Flaherty, Council Member Murphy.

#### **Old Business:**

- Public Engagement Meeting Cairo District Water Rate Increase
  - o 'Initially, RCAP met with the Town to discuss how we might help find funding for needed water projects. As part of our meeting, we became aware that the current water rates are low enough to disqualify the Town from most funding sources and volunteered to provide a rate study at no charge to evaluate if the rates are working for the District and if they should be raised to make them more competitive. Work on the rate study began in September. RCAP has spent the ensuing months collecting and analyzing budgetary, billing, and usage data. We have visited the Town several times for in-person meetings, as well as hours of phone calls and email correspondence. We would like to take a moment to commend the Town Bookkeeper and the Water District Administrator for their patience and persistence throughout the process. Though the report itself is now being submitted to the Town, the work that began in September does not conclude with this meeting. RCAP is still able to provide answers to questions from the Board and the public in response to the report, and we are willing to help with the funding application process as well. Jesse LaVinge'

  - The Town has received a bill from Delaware Engineering for services in the amount of \$6,820.00
- Comprehensive Town Plan Nicole
  - Steps to Begin a Comprehensive Plan
    - 1) Town Board Resolution to initiate process and includes
      - a. Intent to prepare or update a Comprehensive Plan
      - b. Establish a Comprehensive Plan Committee
      - c. Defines the purpose & goals (economic development, housing, recreation, flood mitigation, etc.)
    - 2) Comprehensive Plan Committee with the following representative members:
    - a. Town Board

- b. Planning Board
- c. Other boards /commissions (Zoning, Water & Sewer, Maintenance, Parks, etc.) d.
   Community stakeholders (business owners, civic groups, school district, senior/youth reps).
- Committee Role: guide the process, gather input, draft recommendations.
  - Data collection (demographics, land use, infrastructure, housing, economic trends).
  - Mapping (GIS-based land use maps, environmental features).
  - Public engagement facilitation.
  - Drafting and formatting the Plan document.
- 3) Collect Data & Conduct Existing Conditions Analysis
  - Review and summarize:
    - o Population, housing, and economic trends (Census/ACS).
    - Land use, zoning, natural resources, infrastructure, transportation, recreation.
    - Hazard mitigation/flood risk data (relevant for Cairo's watershed context).
    - Existing plans (Greene County, REDC, 2003/2014 Cairo Comp Plan, NYS OGS Flood report 2023, Angelo Canna Town Park Master Plan, etc.)
- 4) Public Participation Process
  - Required under NYS law; must ensure "maximum feasible participation".
  - Typical methods:
    - Public workshops & visioning sessions.
    - Surveys (online/paper).
    - Focus groups with key stakeholders.
    - Informational website & newsletters.
  - Cairo should emphasize input from youth, seniors, and underserved groups (other languages).
- 5) Draft the Comprehensive Plan
  - The draft must include (per Town Law §272-a):
    - Inventory & analysis of existing conditions.
    - Goals & objectives (housing, economy, land use, environment, community services, etc.).
    - o Policies & recommended actions.
    - Future land use map.
    - Implementation strategies (zoning updates, capital projects, grant funding).
- 6) Environmental Review (SEQR)
  - Adoption of a Comprehensive Plan is a Type I Action under the State Environmental Quality Review Act (SEQR).
  - Town must complete an Environmental Assessment Form (EAF) and determine significance.
  - If impacts are significant, a Draft Environmental Impact Statement (DEIS) may be needed.
- 7) Public Hearing on Draft Plan
  - The Town Board must hold at least one public hearing.
  - Notice of hearing must be published in the official newspaper at least 10 days prior.

- Public input is formally received and considered.
- 8) Referral to Greene County Planning Board (Required)
  - Under General Municipal Law §239-m, the draft plan must be referred to the Greene County Planning Board for review and recommendation (since the plan affects land use/zoning).
- 9) Town Board Adoption
  - After SEQR review, County comments, and public hearings, the Town Board may adopt the Comprehensive Plan by resolution.
- 10) Implementation
  - Update the zoning ordinance and subdivision regulations to align with the new plan.
  - Identify priority projects for grants (parks, infrastructure, flood mitigation, etc.).
  - Set up a schedule for regular review (NYS recommends updates every 10 years)

- 3) St. Joseph's shall pay the full amount of the anticipated building permit application fees and in the event that the above-referenced engineering review fees exceed \$13,000 up to 30% of the application fee shall be allocated toward the reimbursement of such fees; and
- 4) In the event the engineers review exceed such \$13,000 deposit and the 30% allocation the parties shall convene and reevaluate further deposits.
