 - **§ 1. Title.**

This local law shall be known as the “Town of Cairo Alarm Devices and Systems Law.”

§ 2. Definitions.

As used in this local law, the following terms shall have the meanings indicated:

ALARM SYSTEMS – A device or an assembly of equipment which is designed to detect smoke, abnormal rise in temperature, fire, medical emergency or any entry into or exit from a building,

structure or facility and by reason thereof emits an audible response intended to alert persons outside of the premises and/or transmit a signal or message to an emergency agency either directly or through private answering point.

EMERGENCY AGENCY – Any fire, police, 911 or other dispatch center or public or private response agency, without regard as to whether such agency is paid or volunteer.

FALSE ALARM – Any signal activated by a police, fire or medical emergency alarm device, devices or system of police, fire or medical emergency alarm devices which is not the result of natural disaster, act of God, criminal act, fire or other emergency, resulting in police, fire or other emergency services or personnel response. The term “false alarm” shall include human error and equipment malfunction causing the alarm to be activated and which results in the above emergency response. The term “false alarm” shall also include any alarm that is activated and deemed to be excessive or negligent by the respective Fire Chiefs within the Town of Cairo.

§ 3. Registration Required.

A. Effective December 1, 2025, the owner or occupant of any premises in the Town of Cairo upon which a burglar or fire alarm system is operated shall provide the following information, in writing, to the Cairo Town Clerk:

- (1) The name, address and business and residence telephone numbers of the property owner and occupant;
- (2) The property location both by street or postal address and tax roll identification number;
- (3) The number of individual tenants or subtenants occupying the premises; and
- (4) The name, address and business and residence telephone numbers of at least one other person to receive notice of the activation of the alarm system if the owner or occupant of the premises is not available.

B. The Cairo Police Department shall be notified by the owner or occupant within 15 days of any change in the information previously provided.

§4. Automatic cutoff required.

A. No person shall install or maintain an external audible alarm device which does not contain an operation automatic cutoff system which turns off the external audible alarm after a period not to exceed 15 minutes.

B. An automatic dialer connected directly to an emergency agency shall automatically disconnect and/or terminate its message after the message has been transmitted a maximum of two times. Notwithstanding the foregoing, however, the total transmission time of all messages shall not exceed five minutes.

§ 5. Record of false alarms to be maintained

A. A member of the Police or Fire Department who proceeds to a premises in response to the communication of a signal which is determined to be a false alarm shall, within two hours thereafter, file a written report with the Cairo Town Clerk setting forth the date, time, premises, location, whether an owner or occupant was present, whether there appeared to be any fire, unlawful entry, intrusion or other damage to the premises and whether it appeared that the alarm signal was activated by a natural disaster as above described.

B. Any Fire Department, Company or District in the Town of Cairo shall maintain a record of the reports of false alarms transmitted to them from premises in the Town of Cairo.

§ 6. Civil Fee.

The owner and/or lessee of real property to which an emergency agency responds as a result of a false alarm shall pay a fee, after a hearing and determination by the Cairo Town Board, for each such response in each calendar year as set forth below. The Town Clerk shall collect all such fees and shall distribute same in accordance with a motion of the Town Board to be set from time to time.

- A. First false alarm: no fee.
- B. Second false alarm: \$75.
- C. Third false alarm: \$100.
- D. Fourth false alarm: \$500 each.

§ 7. Assessment of costs and expenses

All costs and expenses incurred by the Town of Cairo in connection with any civil fee or penalty for a false alarm, including attorneys' fees, court costs and other professional fees, and which are unpaid for a period in excess of six (6) months shall be assessed to and levied against the real property involved and shall be added to, relieved and included in the Town of Cairo real property tax.

§8. Penalties for offenses.

Any person that does not pay the fee established in this local law or which violates any other provisions of this local law shall be subject to a civil penalty not to exceed \$1,000 for each offense. A separate offense shall be deemed committed upon each day during which a violation occurs, continues or is permitted.

§ 9. Enforcement

The Town of Cairo Code Enforcement Officer or any other peace officer or police officer is hereby authorized to enforce this local law.

- Unsafe Structure – Immediate Actions Required (584 Main Street)
 - (1) Dilapidated Commercial structure (Main Street Garage)
 - (2) Property appears to have discontinued the use of a commercial motor vehicle repair shop
 - (3) There are visual structural defects of the building.
 - (4) The structure hasn't been maintained in years causing severe deterioration to the structural elements of the building.
 - (5) The roof visually appears to need structural repairs or complete replacement. The roof has tattered tarps and tires on it. The block walls are deteriorating in multiple areas. There are missing and cracked blocks or brick on multiple areas of the exterior of the structure. Blocks have fallen onto the ground and into the neighboring properties yard. There are broken and open windows. The chimneys are severely deteriorating and show separation from the structure and are at risk of collapse.
 - (6) There are multiple Window that are broken and there is glass on the ground
 - (7) There is what appears to be a partial collapse on the interior of the structure observed through a broken and open window in the basement of the structure.
 - (8) The roof and chimney are currently in a state of imminent and observable failure. Continued occupancy or use of the structure, or the area directly surrounding it, poses a serious and immediate threat to life and safety of any occupant, neighboring property, public and any trespassers.

SECTION 9-A

Inter-fund advances

General Municipal (GMU) CHAPTER 24, ARTICLE 2

§ 9-a. Inter-fund advances. 1. Definitions. As used in this section, the following terms shall have the following meanings:

(a) "Fund" shall mean a group of accounts set aside for the purpose of accounting for moneys or other resources of a municipal corporation in accordance with the uniform system of accounts prescribed by the state comptroller pursuant to section thirty-six of this chapter and shall include funds established for special improvement districts and other funds containing moneys which, if raised by taxes, special ad valorem levies or special assessments, would be raised by taxes, special ad valorem levies or special assessments levied on property in less than the entire area of the municipal corporation.

(b) "Moneys" shall mean moneys of the municipal corporation raised or received from any source which are held in the custody of the chief fiscal officer of the municipal corporation and are not immediately required for the purpose for which they were raised or received, except proceeds from the sale of obligations or other moneys which, by law, may be used only for stated purposes.

(c) "Chief fiscal officer" shall mean chief fiscal officer as defined in paragraph five of section 2.00 of the local finance law.

2. A municipal corporation may temporarily advance moneys held in any fund to any other fund of the municipal corporation. Any such temporary advance shall be authorized in the same manner as prescribed by general, special or local law for making budgetary transfers between appropriations. Suitable records shall be kept of each temporary advance.

- William Dinger Road
 - Pacifico – Cairo Resident/Tax Payer
 - ‘Just following up on William Dinger Road repairs, as discussed with you at the last Town Board meeting.
Nothing has been done yet, to include taking down the Dead-End sign as well as fixing the roadway.
Now the Cairo-Durham School District is in the process of further damaging the roadway with their irresponsible decision to put solar panels on the property they own, and clear cutting without any regard for storm water planning. (Instead of putting solar panels on the roof and selling the land they have not used since they purchased the land to build the new high school in 1970).
I have attached the letter I sent to all of you before the last meeting. The next to the last paragraph sums up the issue of the Town of Cairo never completing William Dinger Road, including the water and sewer.
Thousands and thousands of taxpayer money have been spent over the years to get to this point.
William Dinger Road is a town road, yet it has not been finished or maintained for many years. What is the game plan going forward? Has money been allocated for the completion of the project in the future?
Taxpayer money has been used to get William Dinger Road to its present condition, and more taxpayer money needs to be spent to get the job finished. If not, the taxpayer money that has already been spent will be wasted. And this is not something that will be acceptable to the Cairo taxpayers.’

I look forward to hearing from the Cairo Town Board in regard to this matter.

- 'The Dead-End sign near the end of William Dinger road cannot be removed at this time. It is further my recommendation that the gate be closed. The area beyond the gate was never improved and is not suitable for vehicular traffic. Removing the sign at this time would imply that it has been improved and would open the Town up to unnecessary liability. Landowners wishing to access their property can do so from Route 32 or from Ann street. In 1977, under Supervisor Dorpfeld, the Town Board adopted a resolution acknowledging the Town roads. William Dinger is listed as .25 miles long. This is the approximate distance from Bross Street to the gate. To improve the section in question would be in the six-figure range. The section behind the school from Bross street to the gate would need to be widened by approximately 6 feet in width along with adjusting all the drainage. This would require removing trees adjacent to the residential properties on the opposite side of the road. I'm certain this would be met with opposition from those homeowners. The entire area would need engineering from Bross street to Route 32 for the drainage along with the associated costs of improving it. If the Town Board would like this to happen (and can justify the cost) the Highway Dept could accomplish it. In regard to the school district putting in solar panels, whereas I cannot speak with authority on the matter, it is my understanding that the school is in fact putting solar panels on the roof however the power they will generate will be insufficient to meet their needs. Thus, the need for the panels in the woods. I visited the area yesterday. The only damage I saw, to what was once the bicycle path, was from erosion. Another area of erosion was filled in with stone. I assume this was done by whomever is doing the work back there.'
